- **Who is eligible to apply for the Arts Council of Calvert County's grants?**

AIE: All K-12 public schools, private schools, and homeschool communities within Calvert County's school system are eligible for the Arts in Education (AIE) Grant, as well as higher education institutions.

CG: Nonprofit organizations that have a 501(c)(3) IRS certificate are eligible to apply for the Community Grant. The organization does not have to be headquartered in Calvert County, but the program funded by the grant must take place in Calvert County and/or be in service to Calvert County residents.

- **How much funding can I apply for?**

AIE: Arts in Education Grant awards are up to \$500 per project.

CG: Community Grant awards are up to \$500 per project.

- **How competitive is the applicant pool?**

AIE: The Arts in Education grant receives an average of 15-25 applications each cycle.

CG: The Community Grant usually receives between 8 and 15 applications each cycle.

- **My event/program is open to people who are not Calvert County residents. Can I still apply?**

If your program is happening within the geographic boundaries of Calvert County, yes.

- **My event/program is being held outside Calvert County. Can I still apply for grant funding?**

AIE: Grant funds may be used to cover expenses for travel to locations in the State of Maryland and Washington, DC.

CG: To be eligible for grant funds, the program or event must be held within Calvert County.

- **My organization is headquartered outside of Calvert County. Can I still apply for grant funding?**

AIE: No, only public schools, private not-for-profit schools, and homeschool communities located in Calvert County are eligible for Arts in Education grants.

CG: Yes, assuming the program, event, or project you are funding is being held within the geographic boundaries of Calvert County or provides a clear and considerable benefit to Calvert County residents.

- **Can I apply more than once for a grant if I have multiple programs that need funding?**

Yes, but keep in mind that if funds are low, grant applicants that have not yet received a grant from the Arts Council will have priority.

- **If my organization/school is partnering with another organization/school on the same project, can we each submit a separate application to get double the funds?**

Yes!

- **Can I use the ACCC grant to cover general operating expenses?**

No, ACCC grants cannot be used for general operating expenses or expenses that are part of the normal classroom/curriculum.

- **I need to amend my grant application. What should I do?**

- **My grant application has been approved! How and when do I get my funds?**

Congratulations! When you receive your grant application results, you can expect funds within 2-4 weeks. A check will be hand delivered to your school (for Arts in Education grants) or to the individual identified as the point of contact on your grant application (for Community grants or Individual Artist grants).

- **My grant application has been denied! Can I re-apply or file an appeal?**

You are eligible to re-apply for the same project if your grant application is denied the first time. Grant applications are reviewed by the committee monthly and funds are awarded to the strongest applications.

- **Some details of my grant-funded project have changed. Do I need to notify the Arts Council?**

- **What is meant by "grant acknowledgement" and how do I do it?**

Grant acknowledgements serve to inform program participants of who has contributed financially to the program. Acknowledgements are required by both the ACCC and the Maryland State Arts Council (MSAC). To learn more about acknowledging ACCC grants, see the Arts Council's grant recognition guidelines.

- **Oh no! Something came up and my grant-funded project can't be completed by the end of the fiscal year. What should I do?**

If by the end of the fiscal year your project has not been completed, contact the Arts Council. Generally, you will be asked to return the unused grant funds and reapply in the current fiscal year. The Arts Council understands things happen and plans change; if unused grant funds are returned, it will not detrimentally affect your chances of receiving a grant in the future.

- **What is a Final Report and how do I file it?**

Your final report is a summary of your grant-funded program and includes details of expenditures, income, and participant demographic information. You can file your final report online at any time after the conclusion of your grant-funded project, but no later than the end of the fiscal year in which your program took place. Failing to submit a final report will impact your ability to apply for future grant funding from ACCC, so don't forget to file your final report!

- **I am new to the organization/school and my predecessor failed to file a final report for the previous fiscal year. What should I do?**
